## Colorado Lottery Welcomes Michael Shea as its Newest Lottery Commissioner

Pueblo, Colo. -- The Colorado Lottery is proud to announce that Gov. Jared Polis has appointed Michael Shea to fill a vacancy on the Colorado Lottery Commission for a four-year term beginning July 2, 2025.

Since 2019, Shea Law, LLC, has represented clients in civil and criminal matters in Colorado district, county, municipal, and federal courts. His governmental affairs practice encompasses municipal and state ballot initiatives, litigation, rulemaking, election law, campaign finance, the Colorado Open Records Act (CORA), and Amendment 41. He also strategically advises clients on municipal and state legislation.

Before entering private practice, Shea served as Deputy Legal Counsel for Gov. Bill Ritter and Gov. John Hickenlooper. His extensive state government experience also includes serving as the Legislative Liaison for the Governor's Office of Information & Technology and two years as an attorney in the Attorney General's Office.

Lottery commissioners are appointed to four-year terms and are limited to two terms. It is composed of five members who are appointed by the Governor with the consent and approval of the Colorado Senate. At least one member of the Commission must have been a law enforcement officer for at least five years; one member must have been a Colorado practicing attorney for at least five years; and at least one member must be a certified public accountant who practiced accountancy in Colorado for at least five years.

When he's not serving his community, Shea enjoys playing games with family and friends, fishing, hiking, cooking, and reading.
